Spot registration will be done for un-registered candidates on the date of counselling.

#### Instructions:

- 1. The candidates are required to produce **all the relevant original certificates** at the time of counselling for verification and the candidates who got admission shall pay the prescribed fee at the allotted college.
- 2. The candidates who have not applied (un-registered) should submit the filled application along with prescribed fee receipt at the time of counselling (Rs.1,000/- for General candidates and Rs.500/- in case of SC/ST/PH (Differently Abled) candidates.
- 3. Sliding will not be allowed for already admitted candidates.
- 4. This notification shall be treated as an individual intimation and no separate intimation will be issued.
- 5. All the candidates are requested to go through the guidelines available in the University website before appearing for counselling.
- 6. Two days before the counselling, college wise vacancy position will be displayed in the University website.
- 7. Since more number of candidates are being called for the counselling, this call does not confer any admission into the course for those who have called for the counselling.

### **Checklist**:

- Pass Certificate cum Memorandum of Marks obtained by the candidatesin the qualifying examination (Intermediate or its equivalent)
- 2) Hall Ticket & Rank Card of AP EAPCET-2024
- 3) SSC or equivalent certificate, showing the evidence of the Date of Birth.
- 4) In case of the candidates belonging to Backward Classes, Scheduled Castes, Scheduled Tribes and EWS, latest certified copy of the Social Status Certificate issued by the competent authority.
- 5) Xerox copies of Bonafide / Study Certificates from 6<sup>th</sup> to 12<sup>th</sup> Class.
- 6) Residential Certificate.

**Note:** Such of the students who are having a break in the years of study for reasons other than failure or those who passed the qualifying examination by private study have to submit this certificate issued by the Mandal Revenue Officer / Tahsildar.

In case, the students have resided in more than one place, separate certificate from the Mandal Revenue Officer / Tahsildar, should be furnished for such places of residence.

- 7) Forms required for the candidates eligible under Farmers Quota seats (40%) (Please see the Information Brochure for details).
  - a. <u>FORM-I:</u> It is a proforma indicating the patta numbers and extent of land owned by the <u>candidate</u> / <u>parents</u> duly certified by <u>the Mandal RevenueOfficer</u> / <u>Tahsildar with office seal</u> and the candidate has to enclose attested Xerox copies of <u>pattadar pass book</u> as an evidence of the extentof land.
  - b. <u>Form-II</u>: It is a proforma to be certified by the Head Master of the Schoolwith office seal that the candidate has studied for a minimum period of four years in schools located in Non-Municipal areas during their period of study from 1<sup>st</sup> class to 12<sup>th</sup> class / Intermediate (Non-MunicipalArea Certificate).
  - c. Form-I and Form-II need to be filled in with the signatures of concerned officials viz., Mandal Revenue Officer / Tahsildar and concerned Head of Institution, respectively, along with office seal. Otherwise, the claim of the candidates under this category will be summarily rejected.
- 8) **Proof of receipt for payment of application fee** for Rs.1000/- (for General) / Rs.500/- for (SC/ST).
